Embe Water and Sanitation Company (EMBEWASCO) is a legal entity under the Companies Act 2015 wholly owned by the County Government of Embu. It is licensed to provide water and sanitation services in Mbeere North Sub County of Embu County.

The Company seeks to fill vacant positions for the Board of Directors. The Board of Directors comprises of the representatives of stakeholders identified by the Company and the Embu County Government.

The Board has two (2) vacancies for representatives of the following stakeholders;

- i. One (1) Director representing the Women Organizations
- ii. One (1) Director representing the Business Community

ELIGIBILITY

To be eligible for appointment, one MUST meet the following criteria:-

- i. Minimum Bachelor's degree from a University recognized in Kenya or equivalent qualifications i.e. Professional qualifications e.g. CPA (K), CS (K), etc.
- ii. Minimum seven (7) years working experience in the core profession or have run own enterprise for a minimum of (7) years
- iii. Must be nominated by a stakeholder group registered with EMBEWASCO
- iv. Must meet the **Fit & Proper Test** criteria by WASREB available on WASREB's website www.wasreb.co.ke. The submitted copy **MUST** be fully signed by the applicant and stamped by a Commissioner for Oaths
- v. Must meet leadership and integrity criteria under Chapter 6 of the Constitution of Kenya 2010: (attach the following documents not older than 12 months at the date of submission):-
 - (a) Certificate of Good Conduct (DCI)
 - (b) Clearance Certificate from Credit Reference Bureau (CRB)
 - (c) Clearance Certificate from Higher Education Loans Board (HELB)
 - (d) Tax Compliance Certificate (KRA)
 - (e) Clearance Certificate from Ethics and Anti-Corruption Commission (EACC)

NOTE

- i. Suppliers and other trading associates of the Company are not eligible for directorship positions at the Company
- ii. Persons in current professional and social relationships with directors of the Company cannot become directors of the Company
